4. Dogs must be current on all shots.
5. Dog costumes must not restrict dog's natural motion.
6. All dogs must have a collar and leash and be kept leashed at all times, except while performing in Class 4 or 5.
7. No dogs in heat are allowed.
8. No award of any kind will be given to a dog in poor physical condition.
9. Any dog shown must be the pet of its handler (foster dogs excepted).
10. Judge's decision is final.
