

**2010 UINTAH COUNTY FAIR FOOD EATING CONTEST
OFFICIAL CONTEST RULES AND ENTRY FORM**

DIVISIONS

There will be 4 different divisions. A women's and a men's division ages 12-18 and a women's and a men's division ages 19 and up. There will be 3 winners in each division. The first place winner will receive \$50.00, second place \$30.00 and third place \$20.00.

CONTEST EATING RULES:

5 contestants for each division will be chosen at random from entries submitted by 1:00 p.m. on Saturday, Saturday July 31st, 2010. Contestant will be competing by eating hamburgers and dill pickles. Winners will be determined by amount of food eaten (by weight) in a 5 minute period.

Should a contestant be observed hiding hamburgers or pickles, dropping them under the table, or placing them on another person's plate, he/she will be deemed in performance of a "picnic profanity" and will be disqualified.

Contestant's who suffer a reversal of fortune and/or urges contrary to swallowing will be disqualified (and possibly laughed at).

The "Chipmunking Rule" will be in effect, which means that all food to count must be swallowed 30 seconds after the buzzer.

Gurgitators who are found to be in violation of the "Chipmunking Rule" will be penalized 1/2 a hamburger.

In the event of a tie, the winner will be determined by a 3 minute dill pickle eat-off with the winner being the one who consumes the most (by weight).

Creative participation is strongly encouraged, but good sportsmanship is required.

Decision by judges is final!

Each registrant MUST sign the liability waiver and release. (See page 2).

10 LB HAMBURGER EATING CONTEST:

4 contestants will be chosen at random from entries submitted before 1:00 p.m. on Saturday July 31st. The first contestant to finish a 10 lb hamburger will be the winner of the prize money. Contest eating rules above apply to this contest. There will not be a second or third place. If no one is able to finish the hamburger in 1 hour, no prize money will be awarded.
